



Leave a Legacy by Including Placer SPCA in Your Will, Trust or Estate

By including the Placer SPCA as beneficiary of your will, trust, IRA/401K, insurance, annuity or other estate plan, you can provide a lifelong gift for the animals and people within our community. With a will or trust, you can provide for the ones you love and make provisions for a favorite relative or friend. You can also make a charitable donation to causes that are important to you and minimize taxes and other expenses.

If you have life insurance, own a home, stocks or other property, you will need a will or trust. Please contact an estate planning professional to help you achieve your goals.

There are many ways to name the Placer SPCA in your will or trust. You may choose to give special assets, a portion of your estate or what is left from your estate after other payments.

Below are some sample wordings for bequests:

Residual (after other bequests or designations are named):

"I give to the Placer Society for the Prevention of Cruelty to Animals (tax ID # 94-2607682), located in Roseville, California, the rest and residue of my estate to be used by the Placer SPCA wherever the need is greatest."

Portion:

"I give to the Placer Society for the Prevention of Cruelty to Animals (tax ID # 94-2607682), located in Roseville, California, _____ % of my estate to be used by the Placer SPCA wherever the need is greatest."

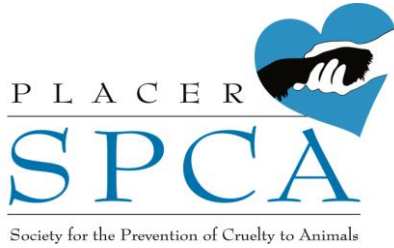
Specific Amount:

"I give to the Placer Society for the Prevention of Cruelty to Animals (tax ID # 94-2607682), located in Roseville, California, the sum of \$ _____ to be used by the Placer SPCA wherever the need is greatest."

Your will or trust can designate a specific amount be transferred as a gift to the Placer SPCA in the form of cash, stocks, bonds, real estate, or any other asset. You may also choose to give a percentage of your estate to the Placer SPCA.
