What other opportunities exist for planned giving?

In addition to wills and trusts, there are many other ways to give that may be beneficial to yourself, your family, and your favorite charity. Popular options include:

- Adding Placer SPCA as a beneficiary to your IRA/401k, life insurance policy, annuity, or Donor Advised Fund (DAF)
- Creating a Charitable Remainder Trust (CRT) or Living Trust
- Transferring other assets such as real estate or appreciated stock to Placer SPCA

What happens after I decide to make a planned gift?

By making a planned gift to Placer SPCA, you are eligible to join our Circle of Hope, made up of people like you who care about animals and want to help other animals find their way into the hearts and homes of people who will love them. As a Circle of Hope member, you will receive invitations to exclusive gatherings and have the option for special recognition.





Surviving Pets Program

Often people forget to make plans for their pets in the event that something happens to them. Placer SPCA established the Surviving Pets program as a way to help animal lovers ensure proper care for their pets in the case they predecease them.

The Surviving Pets program is a free benefit to our Circle of Hope members and our Paw Club supporters that donate a minimum of \$1,000 and renew annually.
